Port Orchard Bay Street Association (POBSA) welcomes applications for Vendors, Artists, Vintage Dealers, Appraisers, Collectibles and Traders, Musicians, Performers and Food Trucks. Please include all necessary information and payment. If, your application is not accepted, you will be notified promptly, and your fee will be refunded. Artists, Performers, Musicians with special space needs be sure to note your preferences below. **Security will be provided on Friday night.**

### VENDOR GUIDELINES

1. Space will be allotted throughout downtown Port Orchard, waterfront parking areas, and pocket parks in 10x10 segments. Artists only, if requested, will be allocated smaller space in front of local downtown businesses. The Fair committee will designate your space based on the Fair needs and your request.
2. POBSA reserves the right to reject any applicant, or limit the number of applicants with similar items. All applications will be screened to ensure that your plans are appropriate for this event.
3. In consideration of the acceptance of this application applicant agrees to indemnify, hold harmless, and defend any action against Port Orchard Bay Street Association, the Port of Bremerton, the City of Port Orchard, and/or their employees and agents from and against all liabilities whatsoever arising out of Vendor's participation in this event.
4. Vendor Applicants for Food Service must provide a certificate of insurance covering their participation at this Fair in an amount not less than \$1,000,000 liability and \$1,000,000 bodily injury naming Port Orchard Bay Street Association, Port of Bremerton and the City of Port Orchard as additional insured. Copies must be provided 30 days prior to the Fair.
5. POBSA will provide onsite security from 9PM Friday to 7AM Saturday to help prevent vandalism and theft. POBSA will not be responsible for loss or damage to any property. Accordingly, each vendor shall take all necessary precautions to protect property and secure valuables. We recommend that nothing of great value be left in booths overnight.
6. Vendor parking will be available in designated areas. All vehicles must be moved by the end of each day's setup period. No departures before the end of each day's show allowed.
7. All vendors must be licensed or otherwise authorized to conduct business in the State of Washington and City of Port Orchard. Vendors are responsible for their own tax, permits, and license and insurance costs and liabilities.
8. Vendors are responsible for providing all tables, tents, and set up equipment. Weights are necessary for tent/awnings. Stakes MAY NOT be driven into the blacktop.
9. Vendors shall not solicit their product or services more than ten (10) feet from their assigned space.
10. No refunds will be given seven (7) days prior to the event.
